



**NOTICE OF ELECTION OF 12 ADD-ON MEMBERS
SIX (6) MALE & SIX (6) FEMALE**

*In accordance with Article III(A), Section 5, as amended, of the Constitution of the District of Columbia Democratic State Committee, the membership of the Committee will elect six (6) Male Add-On Committeemen and six (6) Female Add-On Committeewomen at its regularly scheduled meeting on **Thursday, March 2, 2017**. The 12 candidates, six (6) each per gender who receive the highest vote will be seated and serve until the Annual Meeting held immediately following the 2018 Primary Election. In case of a tie - on March 2, 2017 - an immediate run-off election will be held.*

Interested candidates must meet the following requirements to be placed in consideration.

1. MUST legally reside in the District of Columbia.
2. MUST be registered as a Democrat with the DC Board of Elections and Ethics by February 1, 2017.
3. MUST circulate and return nominating petitions, as prescribed, with a minimum of 100 valid signatures of registered District of Columbia Democrats; or in lieu of signatures may pay a \$100 filing fee.
4. Nominating petitions MUST have a minimum of 10 valid signatures of registered District of Columbia Democrats from each of the city's 8 Wards (including 25 members of the DCDSC). The nominating petitions or the \$100 filing fee must be submitted to the DCDSC: donisaacjr@gmail.com and cc'd edwardsservices@aol.com, (no later than 5:00 p.m. February 21, 2017); and
5. MUST submit a "Declaration of Candidacy" Form AND a general "Statement of Qualification" of 100 words or less no later than 5:00 pm on February 15, 2017 via email to: donisaacjr@gmail.com and cc'd edwardsservices@aol.com.
